

# ANNUAL REPORT OF THE HELLENIC COPYRIGHT ORGANIZATION (OPI) ON ACTIONS AGAINST PIRACY 2010

#### A. Legislative Framework

- 1. Amendment of Copyright Law 2121/1993 (Law 3905/2010 Of. Gaz. 219/A/23.12.2010). Provisions regarding the collective management and some administrative arrangements are included in this latest amendment. Since the last amendment the administrative fine is also applied and to the reproduction and distribution of sound recordings that take place inside shops. Also the Police Authorities of the Ministry of Merchant Shipping are added to the competent enforcement authorities of the administrative fine (**December 2010**).
- 2. A draft provision was sent to the Ministry of Culture and Tourism concerning the non-application of the secrecy of communications with regard to cases of copyright infringement characterized as felony (December 2010).
- 3. Circular sent by the Public Prosecutor in the Supreme Court (Areios Pagos) to all Attorney Generals aiming towards their awareness regarding infringement of copyright and related rights, at OPI's request. (June 2010).
- 4. Remarks to the draft Code of Civil Procedure

Letter to the Ministry of Justice concerning the draft law for the amendment of Code of Civil Procedure in order Article 64 Law 2121/1993 (possibility for ex parte search orders) not to be set aside, since this amendment would be contrary to the acquis communautaire and detrimental for the right holders. (May 2010).

5. Establishment of a special division for copyright cases in the Court of First Instance in Patra

Letter to the Ministry of Justice for the establishment of special division for IP cases in the Court of First Instance in Patra due to the large number of copyright cases (May 2010).

# **B.** Statistics

1. Update of OPI' database (Observatory for Piracy, see below) including statistics from Greek Police, courts and the Municipal Police.



2. Reminder circular (119922/29.11.2010) sent by the Ministry of Justice to the Heads of the Court of Appeals and the Courts of First Instances in order to forward to OPI or to the Ministry of Justice all relevant copyright cases, at OPI's request (October 2010).

### C. Co-operation with other authorities

1. Participation of OPI and submission of proposals to the first meeting of the under formation National Task Force for combating counterfeit goods in the framework of the General Directorate of Customs, Ministry of Finance (September 2010).

### 2. Special Report 301

OPI has actively participated in the formation of the Greek Report as regards the realized national actions for combating piracy and non-entering in the Watch List of the Special Report 301 created by the US Trade Representative Office (USTR).

- 3. Participation in the IPR Co-ordination Committee of the Ministry of Foreign Affairs and its Working Group.
- 4. Creation of a Working Group to combat online copyright piracy.

On **14.05.2010** OPI met at the Ministry of Culture and Tourism with representatives of collecting and collective protection societies, in the presence of the Legal Advisor of the Minister. The major subject of the meeting was **internet piracy**. During this meeting **a Working Group to combat online copyright piracy** was created, composed of representatives of the collecting and collective protection societies.

- 5. On **28.05.2010** a meeting of the Working Group to combat online piracy took place at the premises of OPI focusing on possible solutions.
- 6. Appointment of contact persons by the Custom Authorities, the Finance and Economic Crime Unit (SDOE) and the Municipal Police, at OPI's request, for enabling the co-ordination of enforcement authorities regarding the combat of IPR infringements (February 2010).
- 7. Co-operation with the Ministry of Education
- OPI requested the Ministry of Education to send a circular to schools informing teachers and students about the possibility to find educative



material of OPI in the websites of the Ministry for the needs of lessons where basic principles of copyright are taught (February 2010).

- Letter to the Ministry of Education in order for the relevant educative copyright material of OPI to be uploaded to the new digital platform of the Ministry of Education so as to be accessed by the entire educational community (November 2010).
- 8. Co-operation with the Ministry of Infrastructure, Transport and Networks, General Secretary of Communications

Memo on digital piracy and participation in the meeting of the General Secretary of Communications with representatives of the European Commission about the state of play of the electronic communication market in Greece (October 2010).

## **E.** Education – Raising Awareness

### 1. General Public

• Creation of an Observatory for Piracy on OPI's website (http://web.opi.gr/portal/page/portal/opi/info.html/techhelp.html)

The 'Observatory for Piracy' gathered the entire relevant legal -national and European- framework, the competent authorities, the collecting and the collective protection societies -at national and international level, the relevant national jurisprudence and the latest developments regarding copyright infringement. Finally, a number of useful national, European and international links are



mentioned. The 'Observatory for piracy' is a dynamic website constantly updated with the latest copyright developments. (September 2010).

## • Celebration of the World Intellectual Property Day

In **April** 2010 OPI organized an internet campaign to celebrate the World Intellectual Property Day (26/4/2010) sending press releases to the media, the public administration, the educational institutions, the local government, the bar associations and others.

## 2. Pupils and Students

- OPI informed the Ministry of Education about the 'REAL fake' competition for schools organised by the European Parliament. Aim of this competition was to raise the awareness of pupils and students between 10 and 15 years old regarding the dangers of piracy and counterfeiting, by encouraging them to design a logo or a stamp for the European Observatory on Counterfeiting and Piracy or to produce short stories, games and films, or any other items about the problem of counterfeiting and piracy. The winner of the 1st category for best "Logo/Poster" for the European Observatory on Counterfeiting and Piracy was First High School of Triandria (Thessaloniki).
- OPI in co-operation with the Ministry of Education forwarded its educative electronic material on school websites as additional educational material for students and teachers.

### 3. Publicity actions in the Mass Media

In the context of promoting OPI's aims interviews were given to various periodicals.
